Leaf Collection: The City of Muskego Public Works Department will again be picking up leaves starting the fourth week of October and continuing through November 30th. More information can be found at www.cityofmuskego.org or contact the Public Works Department at 262.679.4128.

Leaf Burning: The City of Muskego Police Department is reminding residents that the burning of any materials of any kind within 20 feet of water courses, lake shores, or drainage ditches is prohibited. The burning of dry brush, dry leaves, and dry plant material is allowed provided winds are less than 15 MPH and the direction of wind is away from buildings. Fires must be 50 feet from buildings, utility poles, or overhead wires. Sufficient fire fighting implements and personnel shall be available at the scene while burning is in progress. No person shall burn garbage, paper, or building debris. Be considerate of neighbors. If annoying smoke complaints are received, the Police Department will order the fire extinguished.
